Household Profile Updates: Collecting Total Family Income (TFI)	<p>Families with a Sponsor or Spouse who work as a DoD Civilian in a DoD Agency or Field Office will now indicate their TFI range in their Household Profile.</p> <p>Total Family Income (TFI) is collected to help MCC match families with all programs that may be available.</p>
Household Profile Updates: DoD Civilian – Agency Selection	<p>Families with a Sponsor or Spouse who work as a DoD Civilian not associated to a specific service can now identify which agency they work for.
